

**DEED OF VARIATION TO THE SUPPLEMENTAL FUNDING AGREEMENT FOR  
NEW COLLEGE PONTEFRACT**

THIS DEED is made the 16 day of December 2021

**BETWEEN**

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) New Collaborative Learning Trust, (the "**Company**") a charitable company incorporated in England and Wales with registered number 09257194, together, the "**Parties**".

**INTRODUCTION**

- A. The Parties entered into a supplemental funding agreement dated 5 May 2017 (the "**Supplemental Funding Agreement**") relating to the establishment, maintenance and funding of New College Pontefract in accordance with the Supplemental Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Supplemental Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Supplemental Funding Agreement.

**1. INTERPRETATION**

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Supplemental Funding Agreement.

**2. VARIATION OF THE FUNDING AGREEMENT**

- 2.1 The Parties agree that with effect from the date of this Deed clause 2.B of the Supplemental Funding Agreement shall be amended to reflect an increase of planned capacity from 1286 to 2900 as follows:

Reference in the Summary page to the Capacity Number shall be amended to 2900

Clause 2.B shall be amended as follows:

"The planned capacity of the Academy is 2900 in the age range 16 to 19"

- 2.2 Except as varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.

**3. GOVERNING LAW AND JURISDICTION**

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

**4. COUNTERPARTS**

4.1 This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
